1. Senior research Officer:: (04 Post) - By deputation:: in the level 11 of pay matrix Rs. 67,700-2,08,700/-(Rs. 15,600-39,100 plus Grade Pay 6,600/- Pre-revised)

Eligibility: From amongst the officers of the Central Government or State Governments or Union Territories or Universities or Public sector Undertaking or Recognized Academic or Research or Training Institution, and Semi-Government or Statutory or Autonomous or Local Bodies:

- a. (i) holding Analogous post on the regular basis in the parent cadre or department; or (ii) with five year's service in the grade rendered after appointment thereto on regular basis in the post in the level 9 in the pay matrix or equivalent in the present cadre or department; and
- b. possessing educational qualifications and experience as under:

 - (iii) Doctor of Philosophy or Doctor of Medicine or Master of Surgery in the relevant field from a recognized university or equivalent or institute or equivalent degree.

 - **Note 2:** The vacancies caused on account of the incumbents being away on deputation (including short-term contract) or on long illness or on study leave on due to any reasons for a duration of one year or more may be filled on deputation basis from the officers of the Central government.
 - **Note 3:** The maximum age limit for appointment by deputation (including short-term contract and deputation on absorption basis) shall not exceed fifty-six years of age as on the closing date for the receipt of applications.
