**NOTICE INVITING TENDER**

National Disaster Management Authority invites quotation for disposal of one Ambassador Car on "**AS IS WHERE IS BASIS**". Interested parties can inspect the vehicle on any working day between Monday to Friday between 11.00 A.M. to 3.00 P.M. from **28.05.18 to 08 .06.2018** at "NDMA Bhawan", A-1, Safdarjung Enclave, New Delhi – 110029 (contact person Sh.A. Sachidanandan, Section Officer, Tele. 011-26701873). Earnest Money Deposit (EMD) and other requisite documents in sealed cover superscribed "Tender for disposal of one staff car (Ambassador)" should be sent to the Under Secretary (Gen.), "NDMA Bhawan", A-1, Safdarjung Enclave, New Delhi – 110029 or the bid document completed in all respects along with may be put in the Tender Box kept in the reception area of NDMA. The last date of receipt of quotation is by 03.00 P.M. on **11.06.2018**. The bid shall be opened on **12.06.2018** at 03.30 P.M. The tenderers, who wish to be present at the time of opening, may do so. The terms and conditions of the contract are as follows:-

**TERMS AND CONDITIONS OF THE DISPOSAL OF STAFF CAR ONE Ambassador(2006)**

1. As per the directions of the E&M Workshop, Airport Authority of India and State Transport Authority, Govt. of NCT of Delhi, the transfer of ownership of auctioned/condemned vehicle cannot be considered. However, a "No Objection Certificate" may be obtained from the Registering Authority for such vehicle for re-registration elsewhere outside NCR Region. The formalities have to be completed by the purchaser.
2. An EMD of Rs. 5,000/- (five thousand only) for vehicle in the form of Demand Draft in favour of DDO, NDMA should accompany the bid. The bids without EMD will be summarily rejected.
3. The successful bidder has to deposit the entire bid money within two working days after the acceptance of the bid. The EMD of Rs. 5,000/- will be forfeited in case the bidder backs out for whatever reason. The EMD of unsuccessful bidder will be returned only after lifting of the vehicle by the successful bidder.
4. The bids received through speed post/registered post/courier/E-mail / Fax/ Telegram will not be considered. **Only online Bids received on CPP Portal will be accepted.**

5. The prospective bidder has to submit authenticated documentary proof of his address. The Department reserves the right to verify the antecedents/documentary proof of his address. In the absence of the information the bids shall not be entertained.

6. The vehicle has to be taken away by the successful bidder from “NDMA Bhawan”, A-1, Safdarjung Enclave, New Delhi – 110029, within 5 days after acceptance of the quotation of the successful bidder. The bid amount by the successful bidder will be deposited in favour of DDO, NDMA.

**7. The disposal will ordinarily be in favour of the highest evaluated bidder, whose bid has been found to be responsive and who is eligible & qualified as per terms & conditions.**

8. Successful bidder will take away the sold vehicle at his own expenses. No assistance / transportation will be provided by NDMA. Permission to take out the sold vehicle from NDMA premises will not be allowed on holidays, Saturday and Sunday, etc.

9. In case the highest quoting firm fails to honour the bid, the next opportunity will be given to the next highest quoting eligible bidder (H2 firm).

10. The vehicle shall be used for bonafide/lawful purpose only.

11. The vehicle will be disposed of on “As is where is basis” and no guarantee to its roadworthiness or quality etc. is given by the Department.
