THE XV Finance Commission has made specific recommendations for “Mitigation Measures to Prevent Erosion” under NDMF and “Resettlement of Displaced People Affected by Erosion” under NDRF. To operate these funds, the Commission suggested that NDMA and/ or Ministry of Home Affairs may develop suitable norms for mitigation measures to prevent erosion under NDMF and the Union and the State Governments to develop a policy to deal with the extensive displacement of people caused by erosion, under NDRF.

To proceed further, NDMA has initiated the process for developing suitable norms for mitigation measures and a policy to deal with the extensive displacement of people. Accordingly, a Draft Policy on Mitigation Measures and Rehabilitation for People Displaced by Coastal and River Erosion was formulated and thereafter consultations with various stakeholders were made. As per inputs/ suggestions of stakeholders, the draft was duly modified and the revised draft was shared with States/UTs, Ministries/Departments, Institutions and Civil Society Organizations (CSOs).

The objective of the policy is to minimize the climate and human-induced risks and maximize the adaptive capacity and resilience of communities affected by coastal and river erosion. The same would be done by way of mitigating and rehabilitating the present and future erosion-related challenges.

In order to finalize the Draft Policy on Mitigation Measures and Rehabilitation for people displaced by Erosion, NDMA is holding a one-day workshop on 17th February, 2023 at KTDC Mascot Hotel, Thiruvananthapuram, Kerala. The purpose of the Workshop is to deliberate on the issues covered in the Policy document with concerned States/UTs, Central Ministries/Departments, Institutions and other relevant stakeholders.

The workshop is organized by National Disaster Management Authority and is co-hosted by Kerala State Disaster Management Authority.
