Appellate Authority of such nodal CPIO will also be accordingly the nodal Appellate Authority.

3. This issues with the approval of Member Secretary, NDMA. In case of vacancy/ leave of any CPIO/ AAs, the concerned link officer will act as CPIO/ AA of that Division.
